(c) During the Seventh Plan, the operations of cooperatives in marketing of agricultural produce is proposed to be expanded further for the benefit of the farmers. The measures to be taken for this purpose include strengthening of their capital base improving their operational efficiency through training of personner, involvement of cooperatives in a large measures in market intervention operations and provision of better credit facilities to cooperatives for their marketing operations.

Closing down of Refractory Units of Burn Standard Co.

- 1355. SHRI SUKOMAL SEN: Will the Minister of LABOUR be pleased to state:
- (a) whether it is a fact that Burn Standard Co. Ltd. has applied for clearance to close its refractory units;
 - (b) if so, what are the details thereof;
- (c) what is Government's action thereon; and
- (d) what steps Government propose to take to help the employees likely to be rendered unemployed as a result thereof?

THE MINISTER OF STATE OF THE MINISTRY OF LABOUR (SHRI T. ANJIAH): (a) to (d) Yes, Sir. The Management of Burn Standard Company Limited have given notices of closure of their Durgapur Works and Raniganj No.2 Works with effect from 20th May 1985 seeking permission of the Central Government for the intended closures under the Industrial Disputes (Amendment) Act, 1982. The matter is under consideration.

CHANDRAKAR): (a) to (do) According to provisional information from States and Union Territories, there were 5579 regulated markets in the country 31.3.1984 Since Agricultural Markets is a State subject, the State and Union Territories have been advised to prepare master plan for setting up regulated agricultural produce markets. Similary, the States and the Union Territories, which have not yet passed appropriate Acts, have been requested to do so to provide for requisite legal framework for regulation of agricultural produce markets.
