REFERENCE TO THE WITHDRAWAL OF ARMY FROM PUNJAB

SHR1 JASWANT SINGH (Rajasthan): Mr. Chairman, Sir, I rise to make a mention of the question of withdrawal of the army from Punjab and the statements made on the subject by the Prime Minister and 'be Home Minister. Sir, the Home Minister's statement, to recall exactly what he said, used the words. "Ia ong form or the other the army will always be present in Punjab." The context of the question which elicited that reply was of law and order, and I had specifically asked in the context of the prevailing law and order situation in Punjab, as the 'army has been the law and order agency in Punjab for the last nine months, when the army was going to withdraw. In answer to which the Home Minister said what he did. Then, Sir, later during the day, the Prim® Minister reportedly made a statement in the meeting of the Congress Parliamentary Party-which statement was carried by the UNI-and in that the Prime Minister is believed to have said that the army is going to ba withdrawn. Subsequently there was a retraction of that statement. Yet again, later in the evening, there was a further contradiction of the retraction and J*1 again, on a subsequent day, there was a further contradiction of both tbe retraction and the contradiction. What takes place within the Congress Parliamentary Party is a matter entirely of concern to the Congress Parliamentary Party and would not ordinarily merit a mention in the House. Yet, when the Prime Minister makes a statement on as important an issue as Punjab, then we cannot ignore ft. Secondly, when two Ministers of the Union Cabinet, on 'as important a subject as the withdrawal of the army from Punjab, make totally contradictory statement—one saying that it will always be there, somewhat sugerfluously and confusingly, and the Prime Minister says that the army is going to he withdrawn-and
