People must have read the 'Blitz' of last week which says that there is a plot to kill the Prime Minister in Paris. They also plan to send squads to Algiers, Cairo and United States, in case the plot fails in Paris. This is a very very serious matter and the stringer of 'Blitz' in Paris has received this call.

Also there was a news item in the "Hindustan Times' that one Mr. Carlos who is known as the international killer and who is on the pay of many people has also been despatched for this purpose. This is a very very serious matter and I do not know how much cognizance the Government has taken of it. I would like to know whether the Government has received any report from the Ambassador in France and what steps it plans to take to protect the life of the Prime Minister on the occasion of holding of Festival of

India in Paris. Also has the French Gov-\
ernment said that they will take the full
responsibility for the visit of Mr. Rajiv
Gandhi and has assured full protection
for him.

REFERENCE TO THE ESCALATING OF IRAN-IRAQ WAR

SHRI SHYAM SUNDAR MOHAPATRA (Orissa): I raise this. Special Mention at a time when the entire world is in the vortex of a global peril because of the escalation of war between Iran and Iraq.

The two architects of Non Aligned Movement, Yugoslavia and India, are conferring how to solve this problem. And already the Egyptian President, Mr. Hosni Mubarak and King Husain of Jordan have arrived in Baghdad to confer with President Saddam Hussain on how to stop the war. The six nation Gulf Cooperation Council leaders have also tried to confer among themselves in Riyad and given the responsibility to Mr. S. K. Sab-hah, the Deputy Prime Minister of Kuwait, to be in touch with Mr. Saddam Hussein.

What I want to bring to notice is the grave peril which the entire world is facing at present. The spokesman of the Government of India said vesterday:

"India fears that the pungency with which the war is now being waged and its engulfing inter-national air and sea lanes poses an imminent threat to the security and peace of the region and therefore the entire world. Rocket attacks on ships and warnings that passenger airlines in enemy airspace would be shot down have added to the tense situation."

This is the bigger dimension of the war. It is more catastrophic than the blood bath in Kampuchea and more disastrous than what happened in Falklands only in 1983. What I suggest, Sir, is that the Non-Ali-gned Movement which has an interest in this must sit in judgement as to how to solve it. Mr. Rajiv Gandhi has already sent two important emissaries—one to Baghdad and one to Tehran-Mr. Venkat-eswaran and Dr. Tejato be in touch with the leaderships of these two countries. Sir, the question is how to solve it. Mr. Saddam Hussain is a great friend of India, whose party—the Arab Baath Socialist Party—and the Indian National Congress have a relationship for the last forty years. We accept his regime as a progressive regime as against the fundamentalist in Iran, although we have deep cultural relations with Iran dating back to three thousand years.

The question is, (1) the troops must be withdrawn to the international border; (2) there should be a peace force in these two zones so that they can supervise it under the leadership of the Non-Aligned Movement. Sir, Basra has been bombarded and the population of Basra is over a million. The lives of a million people today are in danger in Basra. What Iraq has done is, it bombarded the steel plants and industrial installations in Iran. What Iran has done is, it has bombarded the Iraqi cities, killing civilians. Although the Security Council had decided that both these belligerent parties will not attack children, unfortunately, Iran the Red Cross, not attack hospitals and not atack children, unfortunately, Iran has done it Iran has not even attended the Security Council mseting. In this grave situation I suggest that our Prime Minister who is today the Chairman of the Non-Aligned Movement and who has spearheaded cfuite a good number of initiatives.
