मुर्तियों चुराई जा रही हैं और हिन्दू महिलाओं का अपहरण किया जा रहा है गंडों के द्वारा । पुलिस में रिपोर्ट करने के बाद भी पुलिस उस पर कोई कार्यवाही नहीं करती। इतना ही नहीं सरकारी नौकरियों में भी भारी भेदभाव किया जा रहा है। विश्व बैंक योजना के अन्तर्गत क्रिष विभाग में 600 कर्मचारियों की नियक्ति की गई उसमें कल मिला कर हिन्दु समुदाय के 9 लोगों को नौकरी में लिया गया। वहां पर ग्रभी कुछ दिन पहले आगे लगने की दुर्घटना हुई थी। उसमें भी मुख्रावजा देने में हिन्दुओं के साथ भेदभाव बरता गया। इन सारी बातों के कारण वहां के सारे हिन्द समुदाय में एक ग्रातंक ग्रीर भय का वातावरण फैला हम्रा है और जिसके परिणाम स्वरूप व्यापक रूप से बड़ी संख्या में जोग वहां से हटने की तैयारी कर रहे हैं। जम्म-कश्मीर सीमावर्ती राज्य है ग्रीर मैं केन्द्रीय गृह मंत्री जी से श्राग्रह करना चाहुंगा कि इस मामले में वे हस्तक्षेप करें ग्रौर वहां पर ग्रल्पसंख्यक हिन्दू समुदाय ग्रौर विशेष-कर कश्मीरी पंडितों पर जो ग्रत्याचार हो रहे हैं उनकी महिलाओं को भगाया जा रहा है उनके साथ भेदभाव किया जा रहा है उस को रोकने के लिए सक्षम कार्य-वाही करें ग्रौर कांग्रेस (ई) समर्पित गुल शाह की सरकार को यह निर्देश दें कि वे इस प्रकार के भेदभाव को रोकें। श्रीमन, जब फारुख ग्रब्दुल्ला की सरकार थी तो वहां पर एक माइनार्टी कमीशन बनाया गया था ग्रौर उसकी एक रिपोर्ट भी म्राई थी, उस पर कार्यवाही करने के लिए उस समय की सरकार ने वायदा किया था लेकिन गुल शाह की सरकार उस कमीशन की रिपोर्ट पर कोई कार्यवाही नहीं कर रही है। इसके बारे में भी वहां व्यापक ग्रसंतोष है। मैं सरकार से विशेष-कर गृह मंत्री जी से ब्राग्रह करूंगा कि सरकार सारे मामले को देखें और गुल शाह की सरकार को हिन्दू समुदाय ग्रल्प-संख्यक समुदाय की रक्षा के लिए सुनि-श्चित निर्देश दे।

REFERENCE TO REPORTED CRISIS FACED BY INDIGENOUS MANU-FACTURERS OF L.P.G. CYLINDERS

SHRI MOSTAFA BIN QUASEM (West Bengal): Mr. Chairman, Sir. through you, I would like to draw the attention of the Government of India and particularly the Minister in charge of Petroleum and Chemicals to the fact that a serious situation has developed in the indigenous manufacturing units of the L.P.G. cylinders in our country. Some two years back there was temporary shortage of the supply of the cylinders, and the Government permitted the Indian Oil Ltd. and the Hindustan Petroleum to import Cylinders from abroad, speed ficaly Brazil. Taking from Brazil Taking advantage of this situation, these two companies have stopped giving new orders to the units manufacturing the L.P.G. cylinders in the country, as a result of which a serious situation has arisen. My information goes, Sir, that about 50 to 60 such units have already been closed down and that some others are going to be closed down.

And what is a matter of grave concern is this. About 25,000 workmen working in these units are passing through days of utter agony, and they are apprehending retrenchment at any time. Sir, I seek your indulgence to refer to a specific industry the Bharat Brakes and Valves Ltd., a Calcutta-based Government of India undertaking. It was a sick industry and it was nationalised by the Government. It embarked on a policy of diversification to recover from the sickness, not on its own, but at the instance of the Government of India. And because of the encouragement given to the company by the Government, it started production of the L.P.G. cylinders. It obtained permission from the relevant authorities. It had made separate arrangements. had invested funds for this unit, and the workers employed elsewhere were

The order received from the Indian Oil Ltd. was met in due time, and partial supply of the order made by the Hindustan Petroleum was Now this Bharat Brakes and Talves Ltd. suddenly got notice from he Hindustan Petroleum that no longer cylinders would be taken from this company.

in Sir the workmen there are serious difficulties. The company itself is in serious difficulties. The L.P.G. Manufacturers Association, I have the information, have submitted a memorandum to the hon. Prime Minister to look into the matter, and I would also urge the Government for this sake. The Government talks of self-sufficiency and self-reliance, and when the indigenous units are quite capable of supplying the mand necessary at present in country, there should be a stop to import of such cylinders from abroad, and the indigenous units should be given orders for supply of L.P.G. cylinders.
