

(c) The complaint, per 100 tele. Phones per month has declined to 48.3 in the current year as against 49.4 in the year 1983-84

(d) Following measures, are contemplated to make the telephone system fully efficient:—

1. Introduction of sophisticated electronic telephone exchanges.
2. Scrapping of life expired equipment.
3. Installation of electronic trunk auto-exchange to improve the STD services.
4. Laying of new junction and primary and secondary cables in ducts.
5. Provision of primary secondary and junction cables.
6. Use of jelly filled cables in the distribution network;—
7. Rehabilitation of subscribers' fittings and the D.P. Boxes.
8. Provision of high grade junction circuits on PCM and coaxial system.
9. Laying of cables in P.V.C. pipes to avoid damages.

(b) whether there is any proposal under Government's consideration to set up Special Courts for trial of suits for damages filed to be filed by the victims of the MIC gas leaked from the factory of the Union Carbide at Bhopal and if so, what are the details thereof?

THE MINISTER OF STATE OF THE MINISTRY OF LAW AND JUSTICE. (SHRI H.R. BHARDWAJ): (a) and (b) Government would consider initiating action as regards the proper and effective machinery, including amendment of the laws, for securing compensation to the victims of the MIC gas leaked from the Union Carbide factory at Bhopal in the light of the opinion of the Attorney-General. The Attorney-General has gone to the United States to consult American Attorney-General as regard the legal action that may be initiated in the United States for obtaining compensation to these victims.
