- (b) The reasons are given below:
- (1) large scale digging for Metro Railway and by other underground utility agencies such as Electricity Supply, drainage and sewerage, water supply, road development etc.
 - (2) abnormal rainfall in 1984.
- (3) large scale theft of telephone cables and accessories.
- (c) A Task Force has been set up in Calcutta to improve the telephone services by implementing the following schemes:
 - (1) Pressurisation of underground cables.
 - (2) Laying of cables in ducts to prevent damages.
 - (3) Replacement of old cables.
 - (4) Rearrangement of jumpers in cabinets and pillars for quick tracing of faults.
 - (5) Patrolling of telephone cable routes to ensure safety wherever digging is done by other agencies.
 - (6) Flooding of cable trenches before these are closed to detect damages to the cables, if any.
 - (7) Rehabilitation of the distribution points.

- (a) whether it is a fact that the screening of a foreign film entitled "Indiana Johnes" has been banned in India as it presents India in a very derogatory manner;
- (b) whether it is also a fact that some Indian actors have acted in this film; and
- (c) if so, what action Government propose to take to prevent Indian actors from participating in films which present the country in a humi-

liating and derogatory manner?

This film has not yet been presented to the Central Board of Film Certification for the purpose of public exhibition in Inda. As and when it comes before the CBFC, it will be examined in accordance with the provisions of the Cinematograph Act, 1952 and the guidelines issued thereunder.

(b) and (c) There have been press reports that some Indian actors have acted in this film. However, the individual actors are free to act in any film, as no Government permission is required for undertaking this work.
