Setting up of SOS Children's village to rehabilitate gas victims at Bhopal

308. SHRIMATI MAIMOONA SULTAN: Will the Minister of SOCIAL AND WOMEN'S WELFARE be pleased to state:

- (a) whether Government propose to set up SOS Children's villages with a view to helping and rehabilitating the children who were orphaned as a result of the disastrous leakage of the highly toxic gas from the Union Carbide factory in Bhopal, if so, what are the details thereof; and
- (b) whether any arrangements have since been made to provide immediate guardianship to these children by way of adoption and otherwise through various social and voluntary organisations, if so, what are the details in this regard?

THE MINISTER OF STATE OF THE MINISTRY OF SOCIAL AND WOMEN'S WELFARE (SHRIMATI MADGATHAM CHANDRASEKHAR):

(a) No proposal to set up SOS Children's Villages has been received from the Government of Madhya Pradesh A proposal for setting up a Home for 25 children only has been received and this has been approved.

The Government of India have, however, already sanctioned three additional Integrated Child Development Services projects for covering the population affected by gas leakage at Bhopal. Some voluntary organisations have also been advised to get their proposals routed through the State Government for sanctioning grant to them under the Scheme for the Welfare of Children in Need of Care and Protection for rehabilitating the affected children.

(b) The cases of guardianship/adoption are handled by competent Courts which have to be approached by the applicants, desirous of obtaining the guardianship of children

or adopting them according to law. For processing the cases of intercountry guardianship/adoption of Indian children in the Courts, some welfare agencies have been given recognition in accordance with the guidelines laid down by the Supreme Court on the subject in their judgement dated 6 February, 1984 in Miscellaneous Petition CRL-1171/1982.
