were recruited as Constables in the Border Security Force from the Kashmir Valley. One candidate was selected as Assistant Commandant (category A' Post) from the Kashmir Valley but he did not report for training in the Border Security Force. In the C.R.P.F., 23 candidates were recruited as Constables in 1982 from State of Jammu and Kashmir. Break up of recruitment is not available. During 1983 and 1984, 13 candidates were recruited in the C.R.P.F. as Constables from Kashmir Valley.

## **Result oriented administrative reforms**

Will the PRIME MINISTER be pleased to state:

- (a) what administrative reforms are proposed to be made so that results could take precedence over the procedure;

THE PRIME MINISTER (SHRI RAJIV GANDHI): (a) to (c) A review of administrative organisation procedures and practices has been initiated to cut delays, decentralise decisionmaking processes, enforce accountability and simplify rules and procedures. These are aimed at improving efficiency and reduce scope for corruption. The vigilance and anti-corruption machinery will be further strengthened, where necessary. Deterrent punitive action will be taken against those found indulging in corruption.

- (a) whether it is a fact that about 55000 workers of the National Textile Corporation are going to be made surplus and sacked as soon as part of their modernisation plan;

- (c) what are the details of the plan for the rehabilitation of these workers; and
- (d) whether any directive have been issued in this respect?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND SUPPLY (SHRI P. A. SANGMA): (a) and (b) No Sir. However, rationalisation of labour is an ongoing process depending upon several factors c.g. implementation of modernisation programmes, change in product-mix change in capacities and revision of work norms,

(c) and (d) Due compensation would be paid to the affected employees.
