## Price of colour TV sets

(a)' whether it is a fact that the colour TV manufacturers have given an understanding to Government of India that the retail prices of colour

TV sets marketed by them would not exceed Rupees 7500 (Turret tuner) and Rs. 8000 electronic tuner and that this price included guarantee/ warranty and sales tax in Delhi;

- (b) whether Government are aware that the manufacturers have evolved diffrent strategies to keep their profit margin intact and the actual price comes between Rupees 9000 and Rupees 10,000 per set; and
- (c) if so, what action Government have taken against such manufacturers?

THE MINISTER OF STATE IN THE MINISTRY OF SCIENCE AND TECHNOLOGY AND IN THE DE-PARTMENTS OF OCEAN DEVELOP-MENT; ATOMIC ENERGY, SPACE AND ELECTRONICS (SHRI SHTV-RAJ PATIL); (a) Yes, Sir This undertaking was given by Colour TV manufacturers in respect of Colour TV (CTV) sets which were assembled through kits imported on one time basis by the Government during ASiIAD. No other undertaking has been given by Colour TV manufacturers to the Government about the retail prices of Colour TV sets. Indian Television Manufacturer's Association however committed in a meeting with Government that from 15th October, 1984, cost of the CTV to the customer with all taxes and one year guarantee in Delhi will not be more than Rs. 7500 with electronic tuner and Rs. 7000 with turret tuner.

(b)' and (c)' On the basis of a complaint and investigations done under MRTP Act, a 'Notice of Enquiry' has been issued to certain TV manufacturers/dealers for imposing higher costs on the consumres for colour TV sets directly or through service contracts. After necessary investigation a R.T.P. Enquiry has been instituted and the enquery is at initial stage.
