## **Hijacking of Indian Airlines** Boeing Aircraft

- 419 SHRI B. KRISHNA MOHAN: Will the PRIME MINISTER be pleased to state:
- (a) whether it is a fact that some time back an Indian Airlines Boeing aircraft was hijacked and taken to Lahore airport where a revolver was handed over to one of the hijackers before it was taken to Dubai; and
- (b) if so, what action was taken by Government in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI ASHOK GEHLOT): (a) An Indian Airlines Boeing-737 aircraft operating flight IC-421 on August, 24, 1984 from Delhi to Sri-nagar via Chandigarh and Jammu, was hijacked after it took off from Chandigarh. Government have received evidence of handing over a pistol and ammunition by the Pakistan authorities to the hijackers of this aircraft at Lahore airport.

(b) Government made all efforts to terminate the hijacking of the aircraft. The hijackers were ultimately returned by tre Dubai authorities and were token into custody the Delhi at airport. Investigations by the Central Bureau of Investigation into the case have been completed and criminal prosecution of the hijackers will be launched shortly.

Government have also in a communication addressed to the President of the Council of the International Civil Aviation Organisation, requested the International Civil Aviation Organisation Council to take appropriate measures so that there is no recurrence of such a reprehensible act.
