THE MINISTER OF HOME AFFAIRS
(SHRI S. B. CHAVAN): (a) Yes, Sir.

(b) The Force is in the process of being
raised. It will not be in the public interest to
disclose details.

Release of hijackers of Indian Airlines Planes

(a) whether it is a fact that the
Government of Pakistan have finally rejected
India's demand for the release of hijackers of
the Indian Airlines planes and the two planes
hijacked in 1984; and

(b) if so what action is being taken in the
matter?

THE MINISTER OF STATE IN THE
MINISTRY OF EXTERNAL AFFAIRS
(SHRI KHURSHID ALAM KHAN): (a) and
(b) Despite our repeated requests, the Pakistan
Government has neither repatriated to India
nor put on trial the 14 hijackers apprehended
in the Hijacking incidents of September, 1981
and July,

1984. Government are continuing to pursue
the matter with the Government of Pakistan.
The matter has also been brought to the notice
of the International Civil Aviation Organi-
sation.

Narora Atomic Power Plant

429. SHRI VIRENDRA VERMA: Will the
PRIME MINISTER be pleased to state:

(a) the year when the construction work
of Narora Atomic Power Station in Uttar
Pradesh was started and by when it was
scheduled to be completed;

(b) whether it is behind schedule, if so,
what are the reasons therefor;

(c) the date by which power is likely to
be generated from this station and what will
be its capacity in M.W.; and

(d) what were the original estimates for
this station and the amount spent so far and
the amount likely to be incurred till its
completion?

THE MINISTER OF STATE IN
THE MINISTRY OF SCIENCE AND
TECHNOLOGY AND IN THE DE
PARTMENTS ' OF OCEAN DEVE
LOPMENT, ' ATOMIC ENERGY
SPACE AND ELECTRONICS (SHRI
SHIVRAJ PATIL): (a) Financial
sanction for the Narora Atomic Power
Project was obtained in 1974 and
construction work commenced in
1976. At the time of sanction the
two units were scheduled to be com
missioned in 1981 and 1982 respec
tively.

(b) Problems faced in land acquisition,
delay in finalisatiort of design due to
uncertainties regarding avail-

ability of cooling water, seismic requirements etc. and delays in the delivery of major equipment are the main factors causing a slippage in the project schedule.

(c) The two units each of 35 MWe capacity are expected to be commissioned in 1987-88 and 1988-89 respectively.

(d) At the time of financial sanction the station was estimated at Rs. 209.89 crores. Expenditure incurred upto end March, 1984 is Rs. 274.81 crores and the revised sanctioned cost is Rs. 399.64 crores.

दिल्ली में 'ने से पीड़ित लोगों को मुआवजा

431. श्री शंकर सिंह बाघेला : क्या गृह मंत्री यह बताने की कृपा करेंगे कि :

(क) क्या सरकार का ध्यान 10 जनवरी, 1985 के "इंडियन एक्सप्रेस" में प्रकाशित इस आशय के समाचार की ओर दिलाया गया है कि गत नवम्बर मास में दिल्ली में हुए दंगों से पीड़ित अनेक विस्थापितों को अभी तक जान और माल की क्षति से संबंधित समुचित मुआवजा नहीं मिला है और जिनके मुआवजे स्वीकृत भी हुये हैं उनकी शिकायत है कि जो दंग मुआवजे की राशि निश्चित करने के लिए अधिकारियों ने अपनाये हैं, वे मनमाने हैं;

(ख) यदि हां, तो इस संबंध में व्यौरा क्या है; और

(ग) सरकार द्वारा इस संबंध में अब तक की गई कार्यवाही अथवा की जाने वाली कार्यवाही का व्यौरा क्या है?

गृह मंत्रालय में राज्य मंत्री (श्रीमती राम दुलारी सिन्हा) : (क) से (ग) सरकार ने समाचार देखा है दिल्ली प्रशासन

ने सूचित किया है कि 11-1-1985 तक, अक्टूबर-नवम्बर, 1984 में दिल्ली में हुए हाल के दंगों में जान और माल के नुकसान का मुआवजा देने के लिए 19,66.8 अर्बेदन प्राप्त हुये हैं। इनमें से 19,65.0 दावों की जांच की जा चुकी है। 9,515 दावों को स्वीकार किया गया है जबकि शेष मामले ठोस नहीं पाये गए। दावेदारों को 4.30 करोड़ रुपये वितरित किए गए। इससे यह स्पष्ट होता है कि अधिकतर दावों पर विचार किया गया है और उपयुक्त सत्यापन के बाद वास्तविक मामलों में भुगतान कर दिया गया है। दिल्ली प्रशासन ने, मुआवजे की राशि के निर्धारण में कोई मनमानी नहीं की थी। इसका निर्धारण सरकारी आदेशों के अनुसार और दिल्ली के राहत आयुक्त और उपआयुक्त के व्यक्तिगत पर्यवेक्षण में उपयुक्त संवीक्षा और सत्यापन के बाद किया गया।
