Rural electrification in Madhya Pradesh

†*296. MISSANUSUIYA UIKEY: Will the Minister of POWER be pleased to state:

- (a) whether it is a fact that under the Rajiv Gandhi Grameen Vidyutikaran Yojana, the schemes of 47 districts of Madhya Pradesh have been sent to the Rural Electrification Corporation;
- (b) if so, the number of schemes sanctioned so far out of these and the amount involved therein; and
- (c) the status of the pending schemes, the reasons therefor and by when these schemes would be given approval?

THE MINISTER OF POWER (SHRI SUSHILKUMAR SHINDE): (a) Rural Electrification Corporation (REC) has so far received 48 district based Detailed Project Reports (DPRs) from Madhya Pradesh under Rajiv Gandhi Grameen Vidyutikaran Yojana (RGGVY).

- (b) 16 DPRs for 16 districts of Madhya Pradesh involving an outlay of Rs.808.47 crore have been sanctioned so far. Out of these 16 DPRs, 8 projects involving an awarded cost of Rs.532.35 crore are under implementation.
- (c) In addition, 5 DPRs with an outlay of Rs.382.95 crore have been approved "in-principle". The balance DPRs are under scrutiny with REC. The sanction of these schemes will be taken up after approval for continuation of the scheme in the XI-Plan with enhanced funds.

Government of Rajasthan has reported that sanction for providing mid-day meal to 3,25,29,380 students was received by them for the years 2002 to 2005. Out of this, the State Government actually provided mid-day meal to 2,30,65,795 students.
