Review of power situation

571. SHRI F. M. KHAN: Will the Minister of IRRIGATION AND POWER be pleased to state:

- (a) whether Government have recently issued instructions to the State Governments to review the power situation in the country to ensure increase in power generation; and
- (b) if so, what are the details thereof?

THE MINISTER OF IRRIGATION AND POWER (SHRI B. SHANKARA-NAND): (a) and (b) In view of the situation that has arisen out of the power shortage in many parts of the country recently, the Government have initiated talks with several State Governments to review the power situation and to maximise power generation. The talks have been fruitful and the concerned Ministers have assured to take effective measures. The State Governments have been impressed upon the need to take measures to improve thermal performance, accelerate the programme of commissioning new generating capacity, undertake renovation and modernisation of existing plants, and improve training inputs. -

Houses for Government Employees

- (a) whether Government propose to start a crash programme of Housing for Government employees in Delhi; and

(b) and (c) The transmission system associated with the Salal Project provides a transmission line from Salal Project to Udhampur. A 400 KV D/C Kishanpur (near Udhampur) Srinagar Transmission line has been planned under the scope of transmis-
