ORAL ANSWERS TO QUESTIONS

Command area development programme at Kota

- 121. SHRI BHUVNESH CHATURVEDI: Will the Minister of IRRIGATION pleased to state
- (a) whether the Central Government have initiated various works under the Command Area Development Programme at Kota in Rajasthan, during the year 1984-85;
- (b) if so, what is the total estimated expenditure likely to be incurred thereon; and
- (c) whether the projects are likely to receive the World Bank assistance?

THE MINISTER OF STATE IN THE MINISTRY OF IRRIGATION (SHRI RAM NIWAS MIRDHA); The Chambal Project at Kota in Rajasthan is covered under the Centrally Sponsored Com. mand Area Development Programme. The Central Government gives matching assistance to the Slate Government for certain items for such projects included under this Centrally Sponsored Scheme.

- (b) The total estimated expenditure. likely to be incurred in 1984-85 will be about Rs. 198 lakhs.
 - (c) Phase I of the Chambal Project which has already been completed had received World assistance. Bank The State Government has not conveyed their decision on posing Chambal Phase II for World Bank assistance.

SHRI BHUVNESH CHATURVEDI:

Sir, with your permission, I would like to ask the hon. Minister this. Almost three years have lapsed since the Phase I was over, and the Phase II was not taken up. How is the delay explained? The State

Government has shown no interest for Phase II. Does the Minister know that 60 per cent of the employees have been retrenched and agricultural land is being spoilt by water logging and salinity in a big way? In view of the inordinate delay, will the Minister care to visit the site or invite the State Government representatives to discuss and finalise the matter?

SHRI RAM NIWAS MIRDHA: Well, Sir, the First Phase of the Command Area Development Programme has come to an end- It ended in 1982. But the Phase II of the Programme, which should have gone to the World Bank for their appraisal and assistance, has not been sent because the State Government have informed us that they are reviewing the whole Programme, the impact of the First Phase. And they have detected certain shortcomings and difficulties in implementation of the First Phase, in the light of which they want to revise the Second Phase of the Programme. The Committee that has been appointed by the State Government. is headed by the Minister in charge of the CAD Programme himself and we are expecting their final decision on what they propose to do with the Phase II of the Programme of the Chambal Project.

SHRI BHUVNESH CHATURVEDI.

Will you pull up the State Government to expedite We matter? They art sleeping for two years.

SHRI RAM NIWAS MIRDHA; Well, Sir, it is not the policy of the Government of India to pull up the State Governments, and all I can say is, we are constantly in touch with them. I visited the area myself, and if the hon. Member invites, 1 can do so again. "We have met the Minister also. He is also very keen. But they find that there are many problems in the First Phase, which they want to avoid because a lot of difficulties have arisen. There is a lot of public resentment, and one of the things that they have discovered is non-involvement of the beneficiaries and the public representatives in this Programme Many States have done so. but it is not so in Rajasthan. So, in the light of the difficulties that they have experienced as a result of their assessment of the.

success "or otherwise of the First Phase, we are pursuing them to come' for the Second Phase so that it could be proceeded with.

SHRI SHANKARRAO NARAYANARAO DESHMUKH; This Programme was put into action nearly ten years back. So, I would like to Know whether there is any review of the implementation of the Programme for which funds have been released.

Secondly, is there any committee for scrutinising or examining the utilisation of the funds and to ascertain that the funds were not being diverted from the purpose for which they were allotted?

SHRI RAM NIWAS MIRDHA: Well, Sir, review of the CAD programme is being made in a number of cases. Some of these projects are financed by the World Bank. They have been deputing their teams to assess the working of the projects in certain areas. Then, the State Governments themselves have appointed Committees of their own to assess the working of their programmes. They want that the assessment- should be done so that they can change or amend their implementation proposals of other programmes.

Well, Sir, as regards whether the money has been spent or not, we presume that when the State Governments takes on a programme it is utilised for the programme.

माननीय मंत्री जी, क्या यह बताने की ट्रपा करेंगे कि वर्ल्ड बैंक के एक्स-पर्टंस की टीम ने कोई ऐसी रिपोर्ट दी है केन्द्रीय सरकार को या राज्य सरकार को कि जो मंग्रेजों द्वारा केनल सिस्टम बनाया हुआ है, खास तौर से मैं गंगा केनाल सिस्टम के बारे में कह रहा हूं।

भी उपसमापति : यह चम्बल प्रोजेक्ट के सम्बद्ध है। ग्राप इसमें शिफ्ट मत करिए।

श्री सत्यपाल मलिकः यह इससे जुड़ा हुआ है।

श्री उपसभापति: ऐसा मत करिए।

श्री सत्यपाल मिलक: आप कहते हैं, तो हम इस मामले को नहीं कहते हैं। तो सारे सूत्रों में यह हो गया है कि नहर सिस्टम, जो पुरानो नहरें श्री, उनके जो किनारे हैं, उनके वारे में वर्ल्ड बैंक ने रिपोर्ट दी है कि यह बिल्कुल खाउट-डेटेड हो गया है, इससे बिलकुल काम नहीं चलने वाला है, लेकिन स्टेट के पास फण्डस नहीं है। स्टेट उनका रख-रखाव नहीं चरती है।

तो में माननीय मंत्री जो से आनना चाहता हूं कि क्या आप इसको टेक अप करेंगे ?

श्री राम निवास मिर्धाः जैसे आपने कहा यह प्रश्न इससे उत्पन्न नहीं होता, लेकिन फिर भी सामान्य तार से मैं कहना चाहूंगा कि हमारे देश में ऐसी सिचाई की पोजनाएं हैं जो बहुत पुरानों है, सी-सी वर्ष पुरानी हैं और उनका आधुनिकी-करण किस प्रकार हो, यह नमस्या भी सरकार के सामने है और कई राज्य सरकारों ने अपनी पुरानी जो सिलाई की व्यवस्था है, उनका आधुनिकीकरण करने के लिए योजनाएं भेजों हैं । वर्ल्ड बैंक को भी इसमें दिलचस्पों है और अगर राज्य सरकार कोई ठोस योजना लेकर आती है, तो हम उनको समर्थन देते हैं।

New Railway (racks and wagons

*123. SHRI P. N. SUKUL:-)-DR. LOKESH CHANDRA;

Will the Minister of RAILWAYS be pleased to state;

- (a) what is the total route kilometres of railway track added during the year 1983-84; and
- (b) what is the number of wagons put on rails during the same period?

THE MINISTER OF RAILWAYS (SHRI A. B. A. GHANI KHAN CHOUDHURY): (a) 91.01 Kms.

(b) About 17,880 wagons (in terms of four wheelers).

SHRI P. N. SUKUL: In the Ministry of Railway's report for the year 1982-83 that was circulated to us, it is given that 155 Kilometres of new lines were constructed in the year 1982-83. But, Sir, in the budget literature where targets and achievements 'are. given, it has been stated that the larget for the year 1982-83 was 85 kilometres for construction of new lines and achievement was 127 Kilometeres only. So, Sir, these two figures seem to be very much apart from one another In this context, I would like the Minister to explain this discrepancy as to why at two places two figures are provided by the same authorities.

SHRI A. B. A. GHANI KHAN CHOUDHURY: Sir, I have the figures of 1983-. 84 and also of 1984-85. I do not have the figures of...

SHRI P. N. SUKUL: I am talking of 1982-83.

SHRI A. B. A. GHANI KHAN CHOUDHURY: I have the figures of 1983-84. I do not have the figures of 1982-83.

SHRI P. N. SUKUL: It is there in your Ministry's report for 1982-83.

MR. DEPUTY CHAIRMAN: He does not have it at present with him. You put your second question.

SHRI A. B. A. GHANI KHAN CHOU-DHURY: If he gives me notice, I will supply it. I do not have it at present.

SHRI P. N. SUKUL: Sir, our Five Year Plans are essentially development plans, and it is for the planned development of the country that our country chose to embark upon this planning process, of having Five Year Plans. However, as regards the Plan of the Railways, in 1982-83 only 1.03 percent of the expenditure was incurred on development works. In other words, the Plan of the Railways does not seem to be at all a development plan, where only 1 per cent of the expenditure is supposed to be spent on development. In this connection, I would like to point out that originally the Sixth Plan envisaged that one lakh wagons would be acquired by the Railways. Because it is a rehabilitation plan -----it is supposed to be a rehabilitation plan----- this figure was subsequently reduced to 80,000. It was again reduced to 77,000 ---- that is, 77,000 wagons would be acquired during the entire Sixth Plan period. Now the Minister, in reply to another question, has said that the expected acquisition during the whole Sixth Plan period would be 72,000 wagons. From one lakh, we have come down to 72,000, and that is our expectation. We do not know how many we will actually acquire. I would like the Minister kindly to inform the House as to how many wagons have been acquired till date out of the expected 72,000 wagons to be acquired in the Plan period.
