THE MINISTER OF STATE THE MINISTRY OF HOME AFFAIRS (SHRIMATI RAM DULARI SINHA): (a) to (c) Yes, Sir, the 27th Report of the Commissioner has been received by the Government and is being examined. The policy of the Government is that no recognition is accorded to associations formed by Government employees on the basis of Caste, tribe, religion etc.

The Government feel that such recognition will fragement the service into small pockets of employees which will be harmful for the country as well as the services. At the same time, Government cannot prevent formation of such associations as this is a fundamental right under Article 19(1) (C) of the Constitution. In the case referred to by the Hon'ble Member this remark was made by a his individual Judge in separate judgement which did not form part of the final judgement. Bogus visit issuing rackets in Delhi

- (c) In these cases, 35 persons have been arrested. 3 of them are facing trial and the cases against the remaining are pending investigation.
- (d) Wide publicity has been made through the Press, wa ning the public of the modus-operadi adopted by the bogus visa issuing racketeers. The police is vigilant in this regard and prompt action is taken whenever any such case comes to notice.
