## Conference on Europe's roie in North-South **Dialogue**

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI A. A. RAHIM): (a) The Parliamentary Assembly of the Council of Europe organised a Conference on "North-South: Europe's role" from 9-11 April 1934 in Lisbon. In a speech to the Conference Mr. Munir P. Benjenk, Vice-President (External Relations) of the World Bank, referring to the role of the International Development Association (IDA) said, "In India, whose self-sufficiency in foodgrains is one of the great successes of aid-assisted development, and in China, where we have an historic opportunity to support economic reform and liberalisation, IDA's role is being severely limited. Recently we. have been advised that these two countries should be left to seek finance on the market place and use up some of their hardearned reserves. Such action today could all too likely turn them into the Brazils and Argentinas of tomorrow".

Mr. Benjenk also referred to the need for additional concessional finance to reverse the alarming trends in the world's poorest countries and said, "Even India and China, which have fared relatively well during the recession, must be very careful in contracting commercial debt. They are still poor, relatively inflexible economies, and large commercial debt would leave them vulnerable to financial crises some time in the future

(b) The aim of this Conference was to define what Europe can do to invigorate the North-South Dialogue and how to generate the political will to break the present stalemate. Among those who addressed the Conference were the President and Prime Minister of Portugal; the Minister of External Affairs of India (on behalf of the Chairperson of the Non-aligned Movement: the Chairman of the Group of 77; the' Prime Minister of
