Reflations with Neighbouring Coun-. tries

784. SHRI CHATURANAN MISHRA: Will the Minister of EXTERNAL AFFAIRS be pleased to state;

- (a) whether it is a fact that our re lations with neighbouring countries like Pakistan, Sri Lanka, Bangladesh and Nepal are not as good as these ought to have been and there is a feeling in those countries that India is behaving like a big brother;
- (b) whether Government propose to take any fresh measures to remove such feeling and offer a collective security and friendship pact with our neighbours on the basis of no have to any foreign power?

THE .MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO) (a) While relations with other countries, including neighbours, could always be improved, Government do not agree with the assessment contained in (a). From time to time, problems do arise but it is India's policy to resolve all differences in an ami-cable manner through bilateral discussions. There is no intention or desire on the part of India to behave like a big brother.

(b) India and our. neighbours belong to the Non-aligned Movement which provides a framework for cooperation and friendship between member States and precludes the establishment of foreign bases.
