

Ills of Eucalyptus Plantation

869-B. SHRI VISHWA BANDHU GUPTA: Will the Minister of AGRICULTURE be pleased to state:

(a) what steps Government are taking to rectify the social forestry project and to combat the ecological ill's facing the villages of Karnataka, Gujarat, Haryana and Punjab by widespread plantation of eucalyptus tree;

(b) whether it has been established that the Eucalyptus tree is causing degradation of land and has been found to dry-up the water resources; and

(c) if so, what Government propose to do regarding Eucalyptus plantation programme?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI YOGENDRA MAKWANA): (a) Guidelines have been issued to the States to avoid monoculture of Eucalyptus by intimately mixing with other indigenous species. Eucalyptus may be planted depending upon soil, climatic and socio-economic factors to combat ecological ill's.

(b) Of late, there has been criticism that large scale planting of Eucalyptus causes soil degradation and drying up of the sub-soil water. But this has not been scientifically established
