## Increase in the prices of certain drags

(a) whether it is a fact that his Ministry has recently increased the prices of Doxycycline, Amoxicillin, Ampicillin "pi-hydrate and Analgin; if so, what were the old prices and what are the present prices and when the same have been revised:

- (b) whether these drtigs are being sold a: prices at least 30 per cent lower in Ihe market than the prices fixed by Government; what is the basis for increase in the prices of these drugs 'and allowing the formulators to make unintended profits; and
- (c) what steps are being taken to recover the unintended profit under drugs equalisation fund and to reduce the prices of formulations to provide relief to the consumers?

THE MINISTER OF CHEMICALS AND FERTILIZERS (SHRI VASANT SATHE): (a) In the recent past, there has been a revision in price of Doxycycline bulk drug from Rs. 4,000/- per kg. to Rs 5890 per kg.

- (jo) The prices of Bulk Drugs are fixed as per provision of Drug Prices Control Order after taking into consideration the indigenous production from basic stages as well. There have been reports that some bulk drugs imported under REP and/or bulk drugs produced from imported intermediates are available at prices lower than the Government fixed prices.
- (c) Notices have already been issued to the manufacturers of Doxycycline, Amoxycillin Trihydrate Ampicillin Tri-hydrate and Analgin formulations with a view to mop up the unintended benefit. The prices of formulation are under constant review and revision in price is made as and when necessary.
