- (c) whether it is also a fact that the services of some group 'D' employees were appointed on ad hoc basis in July-August, '83 have since been terminated; and if so, what are the details thereof and the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING AND IN DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI H. K. L. BHAGAT): (a) All the six casual workers were appointed as Peons at Doordarshan Kendra, Delhi on purely ad hoc basts. Their regularisation in these posts depend upon the avilability of regular vacancies ia that grade.

However, the services of one Shri Gopal Singh Rwat, the driver of a private car hired by Doordarshan during Asiad, 1982 who was injured in an accident while driving the vehicle and had been appointed on purely ad hoc basis in November 1983 on extreme compassionate grounds as Peon in Doordarshan Directorate, New Delhi were subsequently terminated on the advice of the Deptt, of Personnel and Administrative Refo»ms since his appointment was not in accordance with the prescribe;! procedure.

BHAGAT): (a) and (bl Members of the Central Board of Film Certification and its advisory panels are appointed by the Central Gevernment in exercise of the powers conferred on ft under sections 3(1) and 5(1) Cinematograph Act, 1952 of the respectively. Persons qualified in the opinion of the Central Government to judge the effect of films on the public are appointed a<sub>s</sub> members. While appointing the members Government takes care to see that a cross section of the people is represented on the Board and on the advisory panels. Members come from various walks of life and include "educationists, from legal medical person and professions, psychiatrisfs, social workers, writers, journalists etc.

# Supply of LPG Refills to Army Personnel on transfer

THE MINISTER OF STATE IN THE DEPARTMENT OF PERTROLEUM IN THE MINISTRY OF ENERGY (SHRI GARGI SHANKAR MISHRA): (a) and (b) In pursuance of the instructions issued by the Government, Oil Companies have instructed all their LPG distributors,

including those at Chandigarh a...j Abohar in Punjab to supply refills to Army personnel t>n transfer and residing outside their marketing area. Since these~IS-structions were issued in the last week of April, '84, refusal of supplies of reiil by the distributor at chandigarh and Abohar could have been prior to receipt of these instructions.

# Power Project in Private sector in Tamil Nadu

KHAN): (a) to (c) A proposal received from the Madras Chamber of Commerce envisages setting up of a power project of 110 MW capacity at an estimated cost of Rs. 132.56 orores by a Consortium of Industries in Madras on a co-operattive captive venture to meet the power needs of these industris. The proposal can be considered for approval after the consent and recommendations of 'he Tamil Nadu Elecfricity Board atfeT State Governmentas required under Electricity (Supply) Act. 1948 and Indian Electricity Act, 1910 become available.
