immigration and custom clearance, upgradation of ports infrastructural facilities, connectivity to ports, rationalisation of taxation and cabotage relaxation to promote and develop cruise tourism products. Ministry of Shipping has decided to evolve phased programmes in association with Ministry of Tourism for development facilities at ports for cruise shipping.
