

1269. SHRI M. KALYANASUNDARAM:
Will the Minister of HEALTH AND FAMILY
WELFARE be pleased to state;

(a) whether Government's attention has been drawn to the reports which recently appeared in a section of the press with photographic evidence; of congestion and overcrowding in the various hospitals in Delhi including the All India Institute of Medical Sciences; and

(b) if so, what action Government propose to take in this regard?

THE DEPUTY MINISTER IN THE
MINISTRY OF HEALTH AND FAMILY
WELFARE (MISS KUMUD BEN M. JOSHI):
(a) Yes.

(b) To reduce the pressure on the existing Central Government hospitals, establishment of two 500-bedded hospitals at Shahdara and Hari Nagar and three 100-bedded hospitals at Mangolpuri, Khichripur and Jaffarpur on the periphery of Delhi are under consideration which when commissioned would considerably reduce the load on the existing Government hospitals in Delhi.

medicines prepared by M/s. Glaxo Pvt. Ltd.

1271. SHRI RAM BHAGAT PASWAN: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:-

(a) whether M/s. Glaxo Laboratory Ltd. are manufacturing medicines of several brand names which are harmful and are prohibited by Government;

(b) if so, the details thereof; and

(c) whether any samples of drugs manufactured by M/s. Glaxo Lab. Ltd. were taken during the last two years, and if so, the details thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (MISS KUMUDBEN M JOSHI): (a) and (b) So far as this, Ministry is aware, M/s. Glaxo Labs. Ltd are not producing medicines which are harmful to human health and prohibited by Government.

(c) control over manufacture and sale of drugs is exercised by the State Drug Control Authorities who draw samples of drugs for test. The details are not available with this Ministry.

Production of prohibited drugs

1272. SHRI RAM BHAGAT PASWAN: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) the names and details of companies which are producing prohibited drugs by obtaining stay from the courts; and

(b) the names of the companies which were producing these drugs before the prohibitory order was issued in 1983?

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (MISS KUMUDBEN M. JOSHI):

(a) The names and details of companies which are producing prohibited drugs by obtaining stay from the courts are given in the enclosed statement. (See below)

(b) Under the provisions of the Drugs and Cosmetics Act, the licences for the manufacture of drugs are granted by the State Drugs Control Authorities. Information regarding the names of the firms, products that were licensed from manufacture and are covered by the Notification of 1983 is not available with this Ministry.
