their dis-satisfaction with the offer made. These differences are being discussed by the management with the unions and the results of these discus-'sions are awaited. Government is keen that an amicable settlement is reached as soon as possible.

Ground jobs for medically grounded Pilots¹ of Indian Airlines and Air-India

- (a) whether it is a fact that the Pilots of Indian Airlines and Air India who are grounded on medical grounds are not provided even ground jobs although they are paid full, salaries till the date of their retirement; and
- (b) if so, whether Government Mo— pose to provide ground jobs to these medically grounded pilots because of their long, experience in aviation?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI KHURSHEED ALAM KHAN): (-,) No, Sir

(b) In accordance with the Agreement signed with the Indian Commercial Pilots Association/Indian Pilots Guild, medically grounded Pilots of Indian Airlines and Air India are appointed to ground jobs whenever oos-sible. Alternatively they are paid annuity at rates ranging from 70 per cent to 95 per cent of the basic pay depending upon the number of years ot service rendered by them.
