Supply of Drinking Water on Railways

- 241. SHRI SYED AIHMAD HASHMI: Will the Minister of RAILWAYS be pleased to state":
- (a) Whether it is a fact that the quality of drinking water supplied by Railways for about ten million passengers everyday is generally very poor;
- <b) whether jt is also a fact that the sample testing done in 1981-82 showed that" as many as 29.6 per cent of the samples were not fit for drinking; and
- (c) if so, what action Government have taken in this regard?

THE "MINISTER" OF STATE IN THE MINISTRY OF RAILWAYS (SHRJ C. K. JAFFER SHARIEF): (a) to (c) Sir, the Railway Reforms Committee in its XV Report has pointed out that 29.6 per cent of thg samples tested in 1981-82 were found to be impotable and nave recommended remedial action to be taken.

The unsatisfactory result of dome of the water samples 'tested would be mainly due to inadequate chlorinaffbn or lack of disinfection at specific sources of supplies etc. In such cases immediate remedial action such as enhancing the dose of chlorine or bleaching powder or disinfection of storage Tanks $i_{\rm s}$ taken and the water samples are rechecked for determining its potability. The Railway Reforms Committee's recommendations under active consideration."
