- (b) A representative sample of programmes undertaken is given in Statement T.
- (c) The Bihar State Scheduled Castes Cooperative Development Corporation was established in August, 1978.
- (d) The latest reports available, indicate that loans have been sanctioned to 13710 applicants, upto March, 1983.
