Discovery of oil fields

- 471. SHRI F. M. KHAN. WIII Minister of ENERGY be pleased to state:
- (a) the number of new oil fields discovered in the country during the last two years;
- (b) how many of them have been put into commercial production; and
- (c) what is the taget fixed for production of crude oil in the next four years?

THE MINISTER OF STATE IN THE DEPARTMENT OF PETROLEUM THE MINISTRY OF ENERGY GARGI SHANKAR MISHRA): (a) and (b) Oil was found in eleven new structures during the last two years. Three of these structures are located in an existing known oil field and have been put commercial production. For the remaining eight structures further work is in progress to determine the extent of hydrocarbons accumulations assess the commercial viability of production from them.

(c) A target of production of crude oil for the current year is 29.63 MMT. The targets for crude oil production for next four years would be firmed up after the Seventh Pive Year Plan is finalized.
