STATEMENT REGARDING GOVERNMENT BUSINESS

THE MINISTER OF STATE OF THE MINISTRY OF SCIENCE AND TECHNOLOGY, THE MINISTER OF STATE OF THE MINISTRY OF EARTH SCIENCES, THE MINISTER OF STATE IN THE PRIME MINISTER'S OFFICE, THE MINISTER OF STATE IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS AND THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS (SHRI PRITHVIRAJ CHAVAN): With your permission, Sir, I rise to announce that Government Business during the week commencing Monday, the 19th of April, 2010, will consist of:-

1. Consideration and return of the Appropriation (Railways) No.3 Bill, 2010, after it is passed by Lok Sabha.

SHRI M. VENKAIAH NAIDU (Karnataka): Sir, my submission is, with due respect to the Government, whenever a serious issue comes up and becomes a matter of great controversy, — just now the Minister was saying that the concerned Minister was willing to come and make a statement — then, the Government should come forward and tell the House in the beginning itself that the Minister would like to make a statement and that it would be done at the appropriate time. Otherwise, when the Opposition gives a notice, then, the Chair should allow the Opposition to submit whatever points they want to make, and then, direct the Government to make a statement. Only if it happens the other way round, then, there is hangama ...*(Interruptions)*

MR. DEPUTY CHAIRMAN: We suggested that this could be taken up during the Zero Hour. But that was not agreed to...*(Interruptions)*

SHRI S.S. AHLUWALIA (Jharkhand): Let this be allowed. The Government is not serious about it...*(Interruptions)* The entire country is discussing it. All channels are showing it...*(Interruptions)*
