Birth Control Strategies in Five States

2253. SHRI PARMESHWAR KUMAR AGARWALLA:

DR. DASARI NARAYANA RAO:

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether it is a fact that according to the fact sheets of the Planning Commission, the five States of Bihar, U.P., M.P., Rajasthan and Orissa accounted for 44 per cent of country's population as in 1996;

(b) whether birth control strategies in these States have made little headway so far and they will contribute 55 per cent of the population growth during 1996—2016; and

(c) if so, what effective steps are proposed to be taken to implement population control measures successfully?

THE MINISTER OF STATE IN THE MINISTRY OF

HEALTH AND FAMILY WELFARE (DR. (SHRIMATI) RITA VERMA):

(a) Yes, Sir.

(b) There has been a significant reduction in the crude birth rate and total fertility rate in these five states as mentioned below:

(c) A committee of Secretaries under the chairmanship of Cabinet Secretary is specifically reviewing the implementation of family welfare programme in the States of Bihar, Madhya Pradesh, Rajasthan and Uttar Pradesh on quarterly basis. In the first meeting of National Commission on Population held on 22nd July, 2000, the Prime Minister has announced constitution of an Empowered Action Group attached to the M/O Health which will be charged with the responsibility of preparing area specific programmes, with special emphasis on States that have been lagging behind in containing population growth to manageable limits and will account for nearly half the country's population in the next two decades.
