Extension of third phase of FM

†1129. SHRI RAJIV PRATAP RUDY: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

(c) and (d) Yes, Sir. The private FM radio operators have been raising demands for allowing news and current affairs on their channels. The matter is under consideration of the Government and the guidelines are under finalization.
