THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE [DR. (SHRIMATI) RITA VERMA]: (a) As per revised scheme, private colleges of Indian Systems of medicine & Homoeopathy are not eligible for assistance for construction of building etc.

(b) Keeping in view the priorities and resources, any state-run and state aided colleges are provided assistance for construction work.

(c) There is no such proposal.

#### **Investigation against Advisor of ISM**

2219. SHRI KHAN GHUFARAN ZAHIDI: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether any investigation is pending against any of the advisors of Indian System of Medicines (ISM); and

(b) if so, the details thereof and the action taken against them?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE [DR. (SHRIMATI) RITA VERMA]:

(a) and (b) Allegation of misuse of official position are under examination as per procedure.

#### **Disposal of Hospital Wastes**

2220. SHRI C.M. IBRAHIM: SHRI RAJU PARMAR: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether the menace of disposal of hospital wastes other than through incinerator has assumed colossal proportion in the country;

(b) if so, the number of cases reported or registered in different States, including those with respect to National Institutes and Government hospitals and health centres;

(c) the modes of clandestine disposal of such waste adopted; and

(d) the effective steps adopted to prevent such disposal of wastes?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE [DR. (SHRIMATI) RITA VERMA]: (a) No such specific instances have come to the notice of this ministry.

(b) and (c) Do not arise.

(d) The Government has requested all States/Union Territories to take necessary steps to ensure that the rules as stipulated in the Bio-Medical Waste (Management & Handling) Rules, 1998 are implemented in letter and spirit and to set up an inspection procedure to ensure that disposable items are segregated and treated properly before disposal so that the same are rendered unusable. Prevention of Tetanus Deaths

2221. SHRI KARNENDU BHATTACHARJEE: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether Government's attention has been drawn to the news-item "Tetanus deaths on the rise" published in the Statesman dated 13th July, 2000;

(b) if so, Government's reaction thereto; and

(c) whether Government have any plan to combat this deadly but preventable disease and if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE [DR. (SHRIMATI) RITA VERMA]: (a) No such news item appeared in the Statesman dated 13 July, 2000 of New Delhi and Calcutta editions. However, there is a news item captioned "Tetanus deaths on the rise" in the Statesman dated 14th July, 2000, New Delhi edition.

(b) and (c) As reported by Central Bureau of Health Intelligence, there is significant decline in the number of total tetanus cases and neonatal tetanus cases over the years. Total tetanus cases have declined from 36192 in 1998 to 3588 in 1999 and neonatal tetanus cases from 11849 in 1998 to 1767 in 1999. In order to improve coverage under routine immunization programme, Government is undertaking measures to revamp the Universal Immunization Programme in next 2-3 years by strengthening outreach services, cold chain training, implementation and monitoring.
