Promotion of Indian systems of medicine

- (b) The Department of AYUSH, has *inter-alia* taken the following steps to promote the Indian systems of Medicine:—
 - Mainstreaming of AYUSH under National Rural Health Mission (NRHM).
 - Setting minimum standards for AYUSH Education.
 - Upgrading nine State Government AYUSH colleges as All India AYUSH institutes at a cost of Rs. 650.00 crores.
 - Starting a scheme for Voluntary Certification of AYUSH drugs and accreditation of AYUSH laboratories/hospitals in collaboration with Quality Control of India (QCI).
 - Starting a National Mission on Medicinal Plants at an outlay of Rs. 640 crores.
 - Ensuring participation by credible non-government organizations through Public Private Partnership (PPP) mode in projects in Ayurvedic eye-care, telehomoeopathy etc.
 - Providing re-orientation training to more than 10,000 medical practitioners.
 - Launching multi-media campaigns through audio-visual publicity, outdoor campaigns, Arogya exhibitions (including the North-East), seminars/ workshops/conferences.
 - Starting National Campaigns on specific diseases like Yoga for Health, Unani for Skin Disorders, Ayurveda for control of Anaemia, Amla campaign.
 - Launching a campaign on Yoga and Diabetes in 31 cities in partnership with the Vivekananda Yoga University.
 - Starting National School Yoga programme in 100 districts of the country by involving 5 leading Institutes.
 - Setting up a separate Research Council for the Siddha System of Medicine has been taken.
 - Giving recognition to Sowa Rigpa (Amchi) as a separate system of Medicine.
