

efforts proved instrumental in obtaining a ceasefire between the various parties to the conflict in Northern Lebanon.

(b) During 1983 the Non-aligned Movement continued to press both for immediate measures in areas of critical importance to developing countries as well as fundamental structural changes in the existing international economic order. The proposals put forward by the 7th Non-aligned Summit held in March 1983 were welcomed by the Ministerial Meeting of the Group of 77 held in Buenos Aires in April, 1983 and were incorporated in draft resolutions submitted to UNCTAD-VI held in Belgrade in June, 1983. International economic issues figured prominently at the Summit Level discussions held in New York in September 1983. The NAM Summit proposals on international economic cooperation were actively pursued in various international fora including the 38th Session of the U.N. General Assembly. The response of the developed countries to these proposals, however, has not been very positive.

There has been no significant improvement on the international economic front in relation to the flow of development resources and transfer of technology due to the negative attitude of some developed countries.
