MR. DEPUTY CHAIRMAN: Just a moment, please. Now statement by Minister, Shri P. C. Sethi.

THE MINISTER OF HOME AFFAIRS (SHRI P. C. SETHI): Mr. Deputy Chairman, Sir, while replying to the supplementaries arising out of Starred Question No. 328, answered on the 15th December, 1983, I inadvertently gave out the figures of number of persons injured instead of the number of communal incidents, information about which was sought by a Member, in respect of the States of Andhra Pradesh, Bihar, Delhi, Gujarat, Haryana, Jammu and Kashmir, Karnataka, Madhya Pradesh, Maharashtra during the years 1980, 1981, 1982 and 1983 (up to October 1983). The actual figures as to the number of communal incidents that had taken place in these States in the above order are 116, 218, 15, 214, 7, 21, 110, 101 and 175 respectively.

The number of persons injured is actually 2,838 (not 1,838) in 1980.
