

(b) Yes, Sir.

(c) Government have planned and made projections for the use of available gas in order to avoid flaring. Groups have been set up from time to time to assess the future availability of gas and make recommendations for its use for various purposes such as production of fertilizer and Petro-Chemicals, generation of power, supply to tea gardens, etc. Some associated gas is also re-injected.

(a) whether Government's attention has been drawn to a news item which appeared in the 'Hindustan Times', dated the 20th January, 1984 under the caption "Indian Kuo-Mo scandal" involving India Carbon Limited;

(b) whether it is a fact that the ONGC has suffered a huge loss because India Carbon Limited have defaulted in making payment for the raw material supplied to it;

(c) whether it is also a fact that the Board of Directors of the Indian Oil Corporation at an emergency meeting held on January 7, 1984 had rejected the proposals made by the Energy Ministry in its letter to them; and

(d) if so, what are the details of the proposals made to the Indian Oil Corporation, including the reasons for favouring the said firm?
