## Continuance of Bonded Labour

738. SHRI DHULESHWAR MEENA: Will the Minister of LABOUR AND REHABILITATION be pleased to state:

- (a) whether il is a fact that bonded labour system still exists in Haryana, Punjab, Rajasthar, Bihar and some other parts of the country and
- (b) if so, whet ter Government propose to make a survey to eliminate bonded labour system in the country and if so, •when?

THE MINISTER OF LABOUR AND REHABILITATION (SHRI VEERENDRA PATIL): (;i) The incidence of bonded labour system has been reported only from 11 States vi.. Andhra Pradesh, Bihar, Gujarat, Karnataka. Kerala, Madhya Pradesh, Maharashtra, Orissa, Rajasthan, Tamil Nadu and Uttar Pradesh\_ The remaining State Governments/Union Territories (including Haryana and Punjab) have reported that this system is non-existent in their States/ UTs. As per the-latest reports received from the 11 State

Governments, the total number of bonded labourers identified and freed in the States as on 31-12-1983 was 1,61,075 out of which 1,19,219 have been rehabilitated.

(b) No, Sir. Under the Bonded Labour System (Abolition) Act, 1976, the responsibility for identification, release and rehabilitation of bonded labourers (and for that matter conduct of necessary surveys) rests entirely with the State Governmen':s concerned. The State Governments have been requested, from time to time, to take urgent and effective steps, including undertaking of intensive surveys, to secure early release and rehabilitation of bonded labourers, wherever found existing.
