by the Standing Committee and its various Local Level Committees on issues relating to embankments and river training works. The Commission directed that the decisions taken by the Standing Committee and its Local Level Committees should be appropriately followed up for an early solution of the problems.

Written Answers

- 1.5 The Commission noted the work of the Standing Committee of the JRC on issues relating to water utilisation of Manu, Muhuri, Khowai, Gumti and Dharla/Dudhkumar rivers. The Standing Committee was directed to continue its, discussions and complete its recommendations as early as possible for submission to the JRC for its consideration.
 - 2. Indo-Nepal issues on water resources under discussions:
- 2.1 The major tributaries of the Ganga from the North originate in Nepal and after passing through the Indian territory join the River Ganga. They cause immense misery by recurring floods end shifting of the river course in the Gange-tic plains of UP and Bihar. The problem is further aggravated by the silt load these rivers carry from the upper catchment of Nepal. There is, therefore, an urgent need for harnessing the waters of these rivers by construction storages rod canal systems to provide benefits to both countries in matters of irrigation, flood control etc. The sites where storages can be built are located in Nepal.

Representatives of both the Governments have been meeting at various levels from time to time to discuss the modalities of action to be taken for development of water resources of these rivers for the mutual benefit of both the countries. Discussions between the two Governments are being continued to arrive at an agreement on the development of waters of these rivers. In such discussions which involve other country it is not practicable to indicate a time bound programme for completion of the discussions.
