All the State Governments and Union Territory Administrations have been requested to achieve a norm of one fair price shop for every 2000 persons. They have also been advised to ope^ more fair price shops so that the target of 3.50 lakhs fair price shops can be achieved.

THE MINISTER OF RAILWAYS SHRI A. B. A. GHANI KHAN CHAUDHURY): (a) During the last three ears, viz. 1981-82 to 1983-84 (upto Jan.) he number of train accidents due to neg-igence and dereliction of duty on the art of railway staff is as under:-

Year	No. of train accidents due to staff failure.
1981-82	761
1982-83	514
1983-84 (upto Ja	an.) 391

No accident was directly atributed to ageing track or worn out signaling equip ment, but failure of track was a contributory cause in 26, 20 and 18 train accidents during 1981-82, 1982-83 and 1983-84 (upto Jan.) respectively.

(b) Punitive action including removal from service, compulsory retirement\(^{\text{reduction}}\) reduction in pay and rank, withholding of annual increment and privileges has been taken under Discipline and Appeal Rules against the staff held responsible for causing the accidents. Field Inspections have been intensified. O^ the spot guidance and corrective action is being insured. On the job training and refresher courses are being arranged. The oveiaged track and signalling equipment are being replaced on a programmed basis within the funds available while simultaneously ensuring that the safety standards are not at all transgressed.

MINISTER OF HEALTH AND THE FAMILY WELFARE (SHRI B. KARANAND); (a) and (b) Government has seen the news report relating to deaths due to tuberculosis in the country. The National Tuberculosis Policy has been specifically structured to provide the necessary case finding and curative facilities to those afflicted with the disease and redoes the mortality rate. Under this programme detection, treatment and preventive facilities in 354 district TB centres have been established. In addition, about 300 T.B, clinics are engaged in detection and domiciliary treatment of T.B. patients. Short
