Grant of Financial Assistance to Sheep breeders

1291. SHRI M. BASAVARAJU: Will the Minister of AGRICULTURE be pleased to state:

- (a) whether there is any proposal under Government's consideration to "declare wool as an agricultural commodity for financial assistance to sheep breeders by the National Cooperative. Development Corporation/ national banks for agriculture and rural development/commercial banks;
- (b) if so, what are the details thereof; and
- (c) if the answer to part (a) above be in the negative what are the reasons therefor?

THE MINISTER OF AGRICULTURE (RAO BIRENDRA SINGH): (a) to (c) Under the existing provisions of the National Cooperative Development Corporation (NCDC) Act, 1962, wool cannot be declared as a notified commodity. However, NCDC can provide financial assistance to plan and promote programmes. through coope-rative societies, for the production, processing, export and import marketing, storage, of foodstuffs, which etc., inter-alia, includes meat, whether fresh, frozen dry preserved. It has, therefore, been considered that the NGDC can provide financial assistance to sheep breeders cooperative societies as meat is also a product of sheep: The NCDC has accordingly been advised to entertain proposals for financing sheep breeders cooperative societies received from the State Governments.

The position regarding the availability of financial assistance to sheep breeders, whether by declaring wool as an agricultural commodity or otherwise from National Bank for Agriculture and Rural Development (NABA RD) /commercial banks is being ascertained from NABARD/RBI and the information when received from them

will be placed on the Table of the House.

Central School for Avikanagar

25.29 crores was proposed to the Planning Commission for inclusion in the Annual Plan 1983-84 for Nhava Sheva Port Project. Taking into account the delay in acquisition of land etc., an outlay of Rs. 16.65 crores has been approved in Annual Plan 1983-84 and a provision of Rs. 30 crores has been included in the Annual Plan 1984-85.

Tension in North Eastern Hill University

THE MINISTER OF STATE IN THE MINISTRIES OF EDUCATION AND CULTURE AND SOCIAL WELFARE (SHRIMATI SHEILA KAUL): (a) and (b) The University Grants Commission's Committee on the working of the Central Universities had, among others, made the following observations, on the working of the North Eastern Hill University;

"In our meeting with the students who come from Meghalaya, Naga-land and Mizoram, it was impressed upon u_s (by all the three igroups that they have been (brought together and were 'forced to live together' in spite of different cultures because there is a design to create tensions amongst them. In fact, there are signs of inter-tribal tensions which may have serious consequences, if not attended to urgently and carefully."

While the report of the Committee is yet to be considered by the Government, the North-Eastern Hill University, has been established for the intellectual, academic and cultural advancement of the people of the hill areas in the region, and in pursuance of this objective, i_s making all efforts for the fulfilment of the same.
