(d) The Railway system in India started with Steam Traction. Subsequently Diesel and Electric traction were introduced. The existing steam locomotives have of necessity to be continued in services till these can be replaced. This replacement is dependent upon the availability of funds for electrification and for the manufacture of new diesel/electric locomotives. In pursuance of this policy, 936 steam locomotives were condemned during 1982-83. The expenditure on steam traction is unavoidable because all available diesel and electric locomotives are being utilised for running the more important services and steam locomotives are mostly used for running van and shunting goods services and ordinary passenger trains besides doing the bulk of the shunting work.
