Hon'ble Member has mentioned about Ram Manohar Lohia Hospital. This hospital is in the heart of the city and usually we get more patients there. But it is not true that senior officers do not pay attention to the patients. They are in charge of Casualty Wards and they are taking all possible care of the patients.

SHAN-KARANAND): The Government have been providing adequate assistance and making concerned efforts for the development of Homoeopathy System of Medicine. The Central Council of Homoeopathy is regulating homoepathic education and practice in the country and the Central Council for Research in Homoeopathy is developing and coordinating scientific research in different aspects of this system. The Government are developing the National Institute of Homoeopathy and the Homo¹ eopamic Pharmacopoeia Laboratory. The Government are also giving grants to the private Homoeopathic colleges in the country for the setting up of book banks and purchase of laboratory equipment.
