(c) whether 30 NIS-trained coaches locally available in Assam, who are yet to get appointment, would be appointed against the existing vacancies, in preference over other applicants to fill up the above 32 post?

THE MINISTER OF STATE IN THE MINISTRY OF YOUTH AFFAIRS AND SPORTS (SHRI SYED SHAHNAWAZ HUSSAIN): (a) Yes, Sir.

(b) A major constraint in filling up the vacancies of coaches in Assam as well as other States of India is because of the following factors:

(i) The total availability of SAI coaches in the country being limited to only 1600, and there being a ban on further recruitment, the vacancies in several States could not be filled up.

(ii) The Scheme has been reviewed by the Staff Inspection Unit of the Ministry of Finance, whereby the need for possing of SAI coaches to District Coaching Centres is to be reassessed resulting in reduction of coaches in $e \rightarrow State$.

After a final decision on the study made by the SIU, it may be possible to re-assess the requirement, and based on total availablity, make necessary adjustments to meet the requirement.

(c) As mentioned at points (a) and (b) the Government has imposed a ban on recruitment in SAI, pending final decision on the SIU review report.

THE MINISTER OF STATE IN THE MINISTRY OF YOUTH AFFAIRS AND SPORTS (SHRI SYED SHAHNAWAZ HUSSAIN): (a) The following Stadiums were built at the time of IX Asian Games in 1982:

- 1. Jawaharlal Nehru Stadium
- 2. Indira Gandhi Indoor Stadium
- 3. Talkatora Swimming Pool Complex
- 4. Talkatora Indoor Stadium
- 5. Dr. Karni Singh Shooting Ranges

Out of the above five, the Talkatora Indoor Stadium is being maintained and administered by New Delhi Municipal Corporation.

The remaining four stadia and also the National Stadium (which was renovated/upgraded for the 1982 Asian Games) is being maintained and administered by SAI on behalf of the Govt. of India.

(b) Sports Authority of India has a regular coaching scheme under which sub-junior and junior sports persons are provided with sports facilities and coaching in the disciplines/facilities available at their particular stadia. In addition to above, sports enthusiasts in the senior age group can also utilise the sports facilities under the Pay & Play Scheme.

The following sports activities are continuing (stadia-wise):---

Jawaharlal Nehru Stadium

Regular Coaching: Athleties, Volleyball, Judo, Boxing, Table Tennis, Billiards & Snookers, Weightlifting, Archery, Lawn Tennis, Cricket, Hockey, Basketball and Physical Fitness.

Pay & Play: Tennis, Billiards & Snookers.

Indira Gandhi Indoor Stadium

Regular Coaching: Badminton, Gymnastics, Basketball, Cycling, Wrestling, Weightlifting, Cricket, Boxing, Archery, Judo, Table Tennis and Physical Fitness.

Pay & Play: Badminton.

In addition to the above, the Indira Gandhi Indoor Stadium houses a SAI Training Centre and a Centre of Excellence. A new 10 Mtr. Shooting Range has recently been added to the existing sports facilities.

Talkatora Swimming Pool

Regular Coaching: Swimming, Roller Skating, Billiards & Snookers and Fitness.

Pay & Play : Swimming.

Dr. Karni Singh Shooting Ranges

Regular Coaching: Shooting & Fitness.

Pay & Play: Shooting and Fitness.

Besides hosting regular sports activities, the SAI Stadia are also utilised as venues for National Coaching Camps and National and International competitions.
