As per available information, the current ex-works prices of Soda *Ash* Light of the indigenous manufacturers are iri the range of Rs. 2461.77 to Rs. 2702.50 per M.T. (inclusive of Excise Duty and Central Sales Tax).

Parallel Postal service operating in big cities
