(c) if the answer to part (a) above be in the negative, what are the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI ARIF MOHD. KHAN). (a and (b)) The colonies known as Hargovind Enclave, Anand Vihar and Srestha Vihar are already electrified having general supply mains as well as street lighting. In regard to providing lighting on the main roads of the areas in question, DESU have started electrification of road No. 56 between Chander Nagar and Vivek Vihar. This work is expected to be completed in about 1½ years time. In regard to road extension from Hargovind Enclave to Anand Vihar and Srestha Vihar, street lighting work can be taken up only after the Central verge of the road is completed.

Transfer of Registered offices of companies from Calcutta

(c) whether in all these cases of transfer of registered offices, the views of the West Bengal Government were taken into consideration, and if not, what are the reasons therefor?

Power Shortage

183. SHRI N. P. CHENGALRAYA NAIDU: Will the Minister of ENERGY be pleased to state:

(a) whether shortfall in power availability by the end of the Sixth Plan will be around 16 per cent;

(b) if so, what were the main reasons therefor in spite of the large sums allocated for the purpose;

(c) what efforts are being made during the end of the Sixth Plan to reduce this shortfall;

(d) whether any steps are being considered in this regard during 1984;

(e) what are the main causes of power shortage in various parts of the country despite a good monsoon; and

(f) which States have been greatly affected due to power shortage?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI ARIF MOHD. KHAN): (a) No, Sir. The power shortage by the end of the Sixth Plan is expected to be of the order of 6 per cent.
