

Ocean has been increased during the last two months;

(b) if so, what are the details thereof; and

(c) what steps have been taken by Government for maintaining the Indian Ocean a peace zone, as declared by the UN resolution; if no steps are being taken, the reasons therefor?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO): (a) and (b) The number of US naval ships operating in the Indian Ocean has increased during the last two months. However, details of the number of ships carrying nuclear weapons are not available.

(c) Together with the littoral and hinterland nonaligned States of the Indian Ocean, India is working for the full implementation of the 1971 UN General Assembly Resolution on the Indian Ocean as a Zone of Peace. India and other like-minded non-aligned States have called for the early convening of the UN Conference on the Indian Ocean, and are taking all possible steps through the UN's *Ad Hoc* Committee on the Indian Ocean, to see that the Conference is held as early as possible.

#### Influx of people from Sind, Pakistan

(a) whether it is a fact that people from Sind, Pakistan are entering into Indian territory due to suppression of the Movement for Restoration of Democracy (MRD) by the Pakistan Government;

#### Production of Milk

(a) what is the quantity of milk procured during the last three years, year-wise;

(b) what is the annual production of indigenous milk powder during the last three years, year-wise;

(c) what is the annual quantum of import of milk powder during the last three years, year-wise;

(d) what is the annual average per-capita consumption of milk in the country during the last three years;

(e) whether it is a fact that the procurement of milk and its production indigenously has increased since 1970 when operation flood programme was launched; and

(f) if so, what was the role of the Indian Dairy Corporation and the National Dairy Development Board in the increase of procurement and production with specific reference to Operation Flood Programme?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI YOGENDRA MAKWANA): (a) The milk procurement by the dairy plants in the public and cooperative sectors in the States and U.Ts. during the last three years is as under;

and (f) The estimated milk production in the country has increased since 1970, due to the impact of various Central, Centrally Sponsored and the State Plan Schemes which also includes Operation Flood programmes. The procurement of milk has also increased since 1970 due to setting up of new dairy plants and expansion of existing ones under operation Flood Project as also other Centrally Sponsored and State Plan Schemes.

The National Dairy Development Board, a registered society set up by the Government of India in 1965 provides technical, engineering, advisory, training, research and support activities in milk production, procurement, processing and marketing. It is the technical arm of Indian Dairy Corporation which was formed in 1970 as the agency responsible for providing finances for dairy development. Mother Dairies in Delhi and Calcutta arid feeder balancing dairy at Patna are being managed by National Dairy Development Board at the request of the concerned Governments. The National Milk Grid is in operation as a part of Operation Flood Programme for off-setting the regional and seasonal imbalances in milk production and supply.
