INSAT-1B for their communication purposes?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING AND IN THE DE-PARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) No Sir.

(b) The tele-communication services in the country are provided by the P&T Department. Under the Indian Telegraphs Act, it is an offence to set up private tele-communication unless a licence is obtained form the Ministry of Communication, There can, therefore, be no automatic use by private parties of any alleged spare capacity on INSAT-1B for their communication purposes.

## 'LPG dealer's Commission

1415. SHRI SURESH KALMADI: Will the Minister of ENERGY be pleased to refer to the answer to Unstarred question 1623 given in the Rajya Sabha on the 8th August, 1983 and state whether information relating to the steep fall in the dealer's commission since 1956 has since been collected; and if so, the details thereof?

THE MINISTER OF STATE IN THE DEPARTMENT OF PETROLEUM IN THE MINISTRY OF ENERGY (SHRI GARGI SHANKAR MISHRA): In 1956 only Bharat Petroleum Corporation was marketing LPG and the commission of the distributors worked to 18.72 per cent of the price. Currently LPG is being marketed through Indian Oil Corporation/Hindustan Petroleum 'Corporation/Bharat Petroleum Corporation and the distributor's commission is about 8.39 per cent of the price.
