THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI S. M. KRISHNA): (a) and (b) The Automotive Research Association of India is still carrying out endurance tests on Maruti range of vehicles. The reports received so far do not reveal need for any significant modification.

- (c) The delivery of cars is scheduled to commence by Mid-December, 1983.
- (d) The estimated price of the car is not likely to exceed Rs. 47,500]- excluding local taxes and transport charges. The cost of the van is likely to be the same, while that of the pick-up trucks will be less by about Rs. 2000]-.

Home Minister Visit to riot hit areas of Hyderabad

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI NIHAR RANJAN LASKAR): (a) and (b) The Home Minister visited Hyderabad on 29-9-83. He advised the State Government to bring the situation to normalcy at the Cabinet.

Foreign trade marks

- (b) since when this policy is in operation and with what results;

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI S. M. KRISHNA): (a) and (b) As per Foreign Collaboration Policy, foreign brand names are not ordinarily allowed for use on the products for internal sales, although there is no objection to their use on products to be exported. A condition to this effect is being incorporated in all approvals for foreign collaboration since the inception of Foreign Investment Board.

(c) and (d) No, Sir. However, the policy in this regard is reviewed from time to time.

Land Racketeers in Delhi

Persons killed by extremists in Punjab and Delbi

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI NIHAR RANJAN LASKAR): (a) and (b) According to information furnished by the Government of Puniab 104 persons were killed and 383 persons were injured in the State on account of extremist activities during the period 1-8-1981 to 31-10-1983. Property worth about Rs. 26 lakhs was damaged/looted. accused in such cases have been arrested and 79 of them have been prosecuted.

6 persons were killed and 56 injured in explosions in Delhi in which the involvement of extremists is suspected. 3 persons have so far been arrested in these cases.

Attempt on life of jordanian Ambassador in New Delhi

2035, SHRI RAM NARESH KUSHA-WAHA: Will the Minister of HOME AFFAIRS be pleased to state;

- (a) whether the Jordanian Ambassador in New Delhi was shot at recently in broad daylight:
- (b) if so, what are the details of the incident:
- (c) whether the assailant has been identified and arrested; and
- (d) whether Government have made review of the set up for ensuring safety of deplomats and deplomatic establishments?

THE MINISTER OF STATE IN THE MINISTRY OF HOME. AFFAIRS (SHRI P. **VENKATASUBBAIAH):** (a) and (b) . On 25-10-1983 at about 2-10 P.M., an unknown assailant some shots at the Jordanian Ambassador. while he was coming to his residence on foot. with the intention to kill him. The assailant was seen and chased by a number

of person. The assailant fired more shots in the air to scare the persons who were chasing him and managed to escape.

- (c) A case under section 307/506 IPC and 27/54/59 Arms Act has been registered at P. S. Chanakya Puri and is under investigation. Vigorous efforts are being identify the accused made to and to apprehended him.
- (d) Day and night patrolling has been intensified in the diplomatic areas. Policemen in plain clothes have also been deployed to maintain vigil. Static force has been stationed at different vulnerable places.

Modernisation of Delbi fire service
