Improvement of Slums

2119. SHRIMATI MONIKA DAS: Will the Minister of WORKS AND HOUSING be pleased to state:

- (a) whether it is a fact that the Planning Commission has recen'ly expressed its displeasure on the unsatisfactory working of the scheme for improvement of slums in the country;
- (b) if so, what are the details in this regard and what are the remedial measures 'he Planning Commission has suggested in the matter; and
- (c) what action Government have taken in the matter?

THE DEPUTY MINISTER IN THE MINISTRY OF WORKS AND HOUS-ING (SHRI MOHAMMED USMAN ARIF): (a) to (c) Presumably reference is to the assessment made by the Planning Commission in their Half Yearly Report on the implementation of the various schemes under the 20 point programme. The scheme for the Environmental Improvement of the Urban Slums is operated in the State Sector as part of the Minimum Nerds Programme and it is for State Governments to take suitable remedial measures. The reasons slow progress in the implementation of the Scheme include short-comings in the adequate provision of funds, institutional arrangements, involvement of the community, effective monitoring, building material and maintenance of the assets created. The State Governments Union Territory Administrations have been requested to take necessary steps order to accelerate the implementation of the programme and to achieve the targets fixed. During 1983-84 sum of Rs. 15 crores has been proved in the Central Budget to released to the State Governments as incentive grant for achieving additional performance over and above the approved annual plan targets the States. With the help of Central Incentive Grant, achievement of higher physical targets by most of the States is anticipated.

Degree Course in Mining Engineering

2120. SHRIMATI MONIKA DAS: Will the Minister of EDUCATION AND CULTURE be pleased to state:

- (a) whether the Central Government have received any proposal from the State Government of Karnataka with regard to starting of degree course in mining engineering in Karnataka;
- (b) if so, what are the details in this regard; and
- (c) what action Central Government have taken thereon?

THE MINISTER OF STATE IN THE MINISTRIES OF EDUCATION AND CULTURE AND SOCIAL WEL-FARE (SHRIMATI SHEILA KAUL): (a) to (c) The State Government of Karnataka had submitted a proposal in 1979 for introduction of a Degree Course in Mining Engineering at the School of Mines, Kolar Gold Fields. In pursuance of the recommendations of the Joint Board of Mining neering Education and Training made at its meeting held in 1981 the proposal was not accepted. However, the Joint Board of Mining Engineering Education and Training at its meeting held on 28th November, 1983 has recommended introduction of a degree course in mining engineering at Karnataka Regional Engineering College, Surathkal. The matter will now be processed further by the All India Council for Technical Education and the Ministry of Education,

Allocation of Foodgrains to Madhya Pradesh under National Runal Employment Programme

- (a) the total quantum of foodgrains allocated to Madhya Pradesh under the National Rural Employment Programme during the year 1982-83;

- (d) whether the Central Government have received any request for the enhancement of allocation of soodgrains from the State Government during the current year; and

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI HARINATH MISHRA): (a) A quantity of 15,435 metric tonnes of foodgrains was allocated to Madhya Pradesh during the year 1982-83.

- (b) During the year 1983-84, a quantity of 12,600 metric tonnes of foodgrains have been allocated to the State.
- (c) Reports received from the State Government indicates lifting of 12,600 metric tonnes of foodgrains by the State Government upto the end of October, 1983.

Central University Security Force

2122 SHRI V. VENKA: Will the Minister of EDUCATION AND CULTURE be pleased to state:

- (a) whether the University Grants Cemmission have proposed a plan for a Central University security force on the lines of para-mili ary forces to deal with increasing law and order problems, student unrest, karmachari strikes, faculty agitations etc.;
- (b) if so, what are the salient features of this plan;

- (c) what are the reasons for increasing unrest in the Central Universities; and
- (d) what steps have been taken to minimum unrest during the last three years and what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRIES OF EDUCATION AND SOCIAL AND CULTURE FARE (SHRIMATI SHEILA KAUL): The Question (a) and (b) strengthening the Proctorial existing in Central Universities deal with increasing law and problems, etc. has been under discussion for some time. A meeting of the Committee of Vice-Chancellors sidered these matters on 21st October, 1983. The Committee decided to constitute a Sub-Committee to go into the question in depth and make specific recommendations. The Sub-Commit-

tee is yet to submit its report. (c) and (d) The reasons for incidents of unrest that take place from time to time in Central Universities are varied and in most cases are of a local character. A generalisation in this regard is difficult. Vice-Chancellors of the respective universities have been dealing with the situations of unrest according to circumstances of the case, settling grievances university various sections of the and community through a dialogue enlisting the assistance of law and order authorities only when there is outbreak of violence.
