No case has come to the notice of Andaman Administration where persons having land above five acres were granted financial assistance under Integrated Rural Development Programme.

Will the Minister of SHIPPING AND TRANSPORT be pleased to state;

(a) whether it is a fact that according to a study conducted by the Central Road Research Institute, about Rs. 1500 crores could be saved in fuel consumption and wear and tear of vehicles on roads, by straightening out road-alignments and ensuring a smooth surface, free from potholes and also that road traffic conditions in India are so bad that about 25,000 persons are killed in road accidents every year which is about 62 deaths for every 10,000 vehicles on road and which is the highest death rate in the world; and

(b) if so, what decisions were taken in this regard and result* achieved in each of the last three years?

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI Z. R. ANSARI): (a) Yes, Sir. It is a fact that according to the Road User Cost Study—a Research Project conducted by the Central Road Research Institute, considerable savings in fuel consumption and cost of operation of vehicles can be brought about by improving the geometries of roads, widening the pavements and improvements in the riding quality of roads. The exact amount of savings has, however, not been quantified in the Report.

It is a fact that about 25,000 persons are killed in road accidents every year in the country which gives a very high accident rate for the country as compared to other developed countries in the world.

(b) A view has yet to be taken on the findings of the study.
