(b) what precise steps have been taken to shift the obnoxious and hazardous industries of the colonies to the plots of industrial areas expeditiously?

(a) whether Government's attention has been drawn to a news report appearing in a recent issue of English Weekly (SUN) wherein it has been stated that the Second Antarctica Expedition launched in December 1962 was unsuccessful;

(b) whether it is a fact that expedition failed to achieve its main aim of aircraft landing on the Antarctica;

(c) whether Government are also aware that the indigenous communication system and the prefabricated huts costing Rs. 4 lakhs were a failure;

(d) what was the total expenditure incurred on the expedition; and

(e) whether this unsuccessful expedition will delay our plans of setting up a permanent research station on Antarctica by 1985; and if so, what steps Government propose to take so that the causes which led to the failure of this expedition are not repeated in the third expedition?
