# Report of Central team on floods in Andhra

2783, SHRI RAYAPATI SAMBA SIVA RAO: Will the Minister of AGRICULTURE be pleased to state:

- (a) whether Government have taken any decision on the report submitted by the Central team which visited Andhra Pradesh to assess the losses suffered due to recent floods and cyclone;
- (b) if so, what are the details in this regard; and
- (c) if not, by when a decision is likely to be taken in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI YOGENDRA MAKWANA): (a) to (c) A ceiling of Central assistance of Rs. 2054.31 lakhs has been sanctioned to the Government of Andhra Pradesh for flood relief against floods in August, 1983.

The report of the second Central team which visited the State between 27th:

192

October-1st November, 1983 to assess the damages caused by the cyclone floods in the first week of October, 1983 is under processing. A ceiling of Central assistance is likely to be sanctioned soon. In the mean time, however, State have been sanctioned Rs. 10 crores as a Ways and Means advance, on ad hoc basis, to take up emergent relief measures.

#### National Rural Employment Guarantee Programme

2784. SHRI RAYAPATI SAMBA SIVA RAO: Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) what are the details of the recently introduced National Rural Employment Guaantee Programme; and
- (b) the number of persons provided. employment under the said programme in different States so far?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOP-MENT (SHRI HARINATH MISHRA): (a) Rural Landless Employment Guarantee Programme (RLEGP) has been launched on 15-8-1983 with two basic objectives, viz. (i) to improve and expand employment opportunities for rural landless with a view to providing employment for at least one member of every landless labour household upto 100 days in a year; and (ii) creation of durable assets for strengthening the rural infrastructure which will lead to rapid growth of rural economy. Assistance under this new programme will be provided to State/Union Territory Governments by the Central Government on 100 per cent basis. Funds amounting to Rs. 100 crores have been allocated under the programme during the current year 1983-84 and provision of Rs. 500 crores is proposed to be made during the year 1984-85.

(b) During 1983-84, 60 million mandays of employment and in 1984-85, 300 million mandays is expected to be generated in the entire country under programme.

# Allocation of funds to Andhra Pradesh under IRDP

2785. SHRI RAYAPATI SAMBA SIVA RAO: Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the funds allocated by the Central Government to Andhra Pradesh under the Integrated Rural Development Programme during the current financial year; and
- (b) the amount of expenditure likely to be incurred on the construction and repairs of roads in rural areas particularly in Guntur District?

THE MINISTER OF STATE IN THE DEVELOP-MINISTRY OF RURAL MENT (SHRI HARINATH MISHRA): (a) and (b) Central share of allocation under Integrated Rural Development Programme to Andhra Pradesh is Rs. 1296.00 lakhs for the current year. Macthing share is to be provided by the State Government. Under Integrated Rural Development Programme, funds cannot be utilised for construction and repair of roads.
